APPLICATION TO PLAY THE AIR GAME

Waiver of Liability and Release of Liability

1. I, the undersigned, wish to play Airsoft and/or Paintball (hereinafter referred to as the "Game"). I recognize and understand that by playing the Game, I could become injured in many different ways. Those risks include, for example but not limited to, the risk of injury resulting directly or indirectly from the impact of the BBs or paint pellets used in the Game; injuries resulting from tripping or falling; injuries resulting from possible malfunction of equipment used in the Game; injuries from defects in the equipment used in the Game or in the playing field; injuries from equipment that may be considered unreasonably dangerous or unsafe; and injuries resulting from any action taken by the air gun Game operator(s), hereinafter referred to as the Sponsor(s), which include but are not limited to the Old Coronach Street Festival and Paintball Paradise. In addition, I recognize that I may suffer injuries even if I am playing the Game as set forth by my Sponsor(s) or from overexertion in playing the Game. I recognize that these injuries could be serious, including, by example and not limited to, loss of sight or even death.
2. I have read and fully understand Paragraph 1 and the risk of injury described in Paragraph 1. I still wish to play the Game. I understand that by signing this application to play the air gun game, I release, discharge, and agree to hold harmless and indemnify the Sponsor(s), including the Old Coronach Street Festival, Paintball Paradise, and their employees, agents, representatives, successors, and assigns from any and all liability of any kind or nature, including but not limited to liability for injuries from the hazards or dangers described above, from any and all claims, including for example but not limited to claims for negligence, strict liability, and others, actions, suits, procedures, costs, expenses (including attorney's fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Game, including without limitation those resulting from the manufacture, selection, delivery, possession, use, or operation of the equipment or from any acts or omissions of the Sponsor(s) or their employees, even if such acts constitute negligence or misconduct. I hereby release the Sponsor(s) from any and all such liability and understand that this release shall be binding upon my estate, my heirs, my representatives, and assigns. I hereby certify to the Sponsor(s) that I am in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing the Game.
3. I understand that eye protection is required at all times. Paintball Paradise Regina provides eye protection goggles, and I promise to use all protective gear during my time at Paintball Paradise Regina as part of the Old Coronach Street Festival event.
4. I hereby promise to play the Game only in accordance with the rules of the Game as set forth by the Sponsor(s), and state that I am eighteen years of age, or six to eighteen years of age and my parent or legal guardian has read and signed this waiver on my behalf.
5. I also agree that paintballs used at Paintball Paradise during the Old Coronach Street Festival must be supplied by Paintball Paradise, and that paintballs bought from a different vendor will not be used at this location.
