

TOWN OF CORONACH - BYLAW 8.2019

A BYLAW FOR THE OPERATION OF A GOLF CART ON THE PUBLIC ROADWAYS WITHIN THE LIMITS OF THE TOWN OF CORONACH

The Council of the Town of Coronach, in the Province of Saskatchewan, enacts as follows:

Short Titles:

1. This Bylaw may be cited as operation of a golf cart on public roadways within the town limits

Definitions:

2. "Golf Cart" as prescribed in The Traffic Safety Act.

Regulations:

3. Persons operating a golf cart must be using the cart for the sole purpose of traveling to/from the golf course using the shortest, most direct route between the golf course and where the golf cart is stored.
4. No one shall operate a golf cart on a public roadway within the limits of the Town Of Coronach without a valid class 7 driver's license, abiding by all SGI regulations and requirements and under Section 113.1 of The Traffic Safety Act.
5. It shall be lawful to operate a golf cart during the hours one-half hour prior to sunrise and one half-hour after sunset on all public roadways, within the limits of the Town Of Coronach, with the exception of any sidewalk, boulevard, school yard, park or playground.
6. No one shall operate a golf cart on Provincial Highway No.18 within the limits of the Town of Coronach except for crossing over Provincial Highway No. 18.
7. The golf cart shall carry a slow-moving warning device at the rear, as near to the center as possible with one side parallel to the ground.
8. Owners must carry a minimum of \$200,000 in third-party liability insurance and all personal and public liability will be the responsibility of the operator of the golf cart.
9. Any person who contravenes any of the provisions of this Bylaw is guilty of an offense and liable on summary conviction to a fine of not less than \$150.00
10. This Bylaw shall come into force and take effect upon approval thereof by Saskatchewan Government Insurance.


