LICENSE BYLAW NO. 5 of 1976

A BYLAW OF THE VILLAGE OF CORONACH FOR THE LICENSING, REGULATIONS AND GOVERNING OF PERSONS ENGAGED IN CERTAIN OCCUPATIONS AND PLACES USED FOR CERTAIN PURPOSES IN THE VILLAGE OF CORONACH.

THE COUNCIL OF THE VILLAGE OF CORONACH IN COUNCIL ASSEMBLED HEREBY ENACTS AS FOLLOWS:

1. This Bylaw shall be cited as "The License Bylaw".

2. INTERPRETATIONS:

In this Bylaw, unless the context otherwise provides, the expressions:-

(a) Business, Boarding House, Hawker and Pedler, Person, Restaurant, Residents, Revised Assessment Roll and Transient Trader, shall have the same meaning as given to them in the Urban Municipality Act, 1970.

(b) "Village" shall mean the Village of Coronach.

(c) "Chief of Police" shall mean the Chief of Police of the Village of Coronach and anyone acting as such during his absence from duty for any cause whatsoever.

(d) "Contractor" shall mean a person (or persons) who is resident of the Village and on The Village Business Assessment Roll and who actually distributes the product to retailers and/or customers, by vehicles owned by him or vehicles licensed under this Bylaw.

(f) "License Inspector" shall mean the Inspector of Licences of the Village of Coronach or Secretary-Treasurer or Administrator, or anyone acting as such during his absence from duty for any cause.

(g) "Resident" or "Residence" shall mean a person living in and carrying on business or calling, in the Village of Coronach, continuously for a period of three months or more.

3. The following shall be the duties of the Secretary-Treasurer or Administrator under this Bylaw:

(1) To attend meetings of the Finance Committee or the Council whenever requested to do so, or when he may find it necessary to do so on business connected with the duties of his office.

(2) To keep a License Register showing the following particulars:

- (i) Names of all persons applying for license.
- (ii) Names of all persons to whom licenses have been granted, with amount of license fee collected in each case.
- (iii) Names of all persons to whom licenses have been refused.
- (iv) Names of persons to whom licenses have been transferred with amount of transfer fee collected.

(3) To report monthly on the following matters:

(i) the number of licenses granted or transferred since last report, with particulars thereof.

(ii) The amount of money received since last report and the total amount of receipts during the year to date of this report.

(4) To report to the Finance Committee any failure on the part of any person to comply with the provisions of this Bylaw, and under the direction of the committee, to prosecute all persons guilty of offences against the Bylaw.

(5) In conjunction with the Mayor of the Village of Coronach to sign all transfers or licenses issued under the provisions of this Bylaw and to keep full particulars thereof.

4. LICENSES REQUIRED:

No persons shall carry on any of the several trades, occupations, callings or businesses hereinafter specified, in the Village of Coronach, until he procures a license pursuant to this Bylaw and every person so licensed shall be subject to the provisions of this bylaw.

5. APPLICATIONS FOR LICENSES:

All applications for licenses shall be in writing and on a form to be supplied by the Village office and shall contain the following information.

- (1) The name, address and occupation of the applicant.
- (2) The nature of the license applied for.
- (3) The place where the proposed trade or calling is to be carried on.
- (4) Where bond is required, the names of the bondsmen or sureties or the name of the Guarantee Company prepared to issue the necessary Bond of Indemnity, as the case may be.
- (5) In case the applicant desires to open a theatre, exhibition show or other place of amusement, the nature and description and seating capacity thereof.

6. LICENSE FEES:

The fee payable in respect to any license required under the provisions of this Bylaw shall be the amount set out in Schedule "A" to this Bylaw and shall be paid to the Village Secretary-Treasurer at his office in the manner hereinafter set forth:

- (1) In case of new applications for license, the prescribed license fee shall be paid in full at the time of filing the application.
- (2) All renewal license fees shall be paid on or before January 31st in each year. An applicant for renewal license, who is not in a position to pay full license fee on or before the date herein stated, may apply to the Council for the privilege of paying the license fee in two half-yearly installments payable in advance.

7. GRANTING OF LICENSE:

- (1) In the case of applications for renewal of licenses, the Secretary-Treasurer or Administrator may grant such license without referring the application to the Council, unless, in his opinion, circumstances warrant referrance of the application for Councils's approval.
- (2) In the case of new applications for licenses, no license may be granted unless and until the application has been approved by the Council.
- (3) Where under the provisions of this Bylaw a bond or surety is required, no license may be issued until the applicant has filed with the Village Secretary a good and sufficient bond to the Village in the sum specified in this Bylaw.
- (4) In all cases where the Legislature of the Province of Saskatchewan requires any person to obtain a Provincial License in respect to any business, no license shall be granted under the provisions of this Bylaw unless and until the applicant shall have first obtained and produced a Provincial License and, in such case, the number of the Provincial License shall be shown on the application for a Village License.
- (5) If the trade, occupation or business is one for which a certificate from the Medical Health Officer or the Sanitary Officer is required, no license shall be issued until and unless said certificate has first been obtained and produced.

8. DURATION OF LICENSE:

- (a) Every license granted under the provisions hereof, unless specifically mentioned to be for a shorter period and unless it shall sooner become forfeited, shall be for the year current at the time of issue thereof, and shall expire on the 31st day of December next succeeding the date of issue.
- (b) When a person is licensed hereunder and has not the required resident qualifications but later qualifies insofar as residence is concerned he shall not be entitled to any rebate of the license fee so paid regardless of whether he is paying business tax or otherwise.

9. TRANSFER OF LICENSES:

- (1) Subject to the provisions of this Bylaw and with the approval of Council, a license granted pursuant to the provisions of this Bylaw may be transferred from one person to another, or from one premises to another premises, on the payment of a transfer fee of three dollars (\$3.00) to be paid at the time of the application; PROVIDED that the provisions of this Bylaw to transient traders, book agents, canvassers for subscriptions to newspapers, magazines and periodicals, and persons licensed under the Direct Sellers Act.
- (2) No license may be transferred unless application is in writing, on a form to be supplied by the Village, and has been filed with the Village Secretary and the prescribed fee paid; and, if the application is for transfer of license from one person to another, the holder thereof must have endorsed on the back of the license a note of his willingness to have the license transferred, stating the name and address of the transferee.
- (3) No license may be transferred from one person to another unless the application is approved by the Council and, where approval is not granted, the fee paid by the applicant forthwith be refunded.
- (4) Every person who shall purchase the interest of a person licensed in any business, calling, article or thing, in respect of which a license has been issued under provisions of this Bylaw and shall carry on or continue said business or calling or keep and use such article or thing without having first procured a license so to do or a transfer of the original license, shall be deemed guilty of an infraction of this Bylaw and shall be subject to the penalties herein.

10. DISPLAY OF LICENSES:

- (1) Every licensee granted a license to carry on a business, who occupies premises in connection therewith, shall keep the license posted in a conspicuous place on the licensed premises.
- (2) All persons licensed under the provisions of this Bylaw where there are no licensed premises shall, on demand of the License Inspector or other person duly authorized in that behalf, produce the license to such official.
- (3) Wherever in this Bylaw a licensee received a license plate from the License Inspector in connection with the granting of a license, the said plate shall be displayed at all times as directed by the License Inspector.

11. REVOCATION OF LICENSE:

- (1) The Council may by resolution suspend or revoke any license granted under the provisions of this Bylaw.
- (2) There a license is revoked, the licensee shall be entitled to a refund of a part of the license fee proportionate to the unexpired part of the term for which it was granted.

12. TRANSFER BUSINESS FROM BUSINESS TAX TO LICENSE:

The Council may by Bylaw transfer any business from the Business Tax Assessment Roll to a license, and upon transfer the license fee will become due immediately.

13. PARTNERSHIPS:

In all cases of partnership firms (except hawkers and pedlars, book agents, magazine, periodicals and newspaper subscription canvassers, and such other exceptions as may be expressly set forth in this Bylaw), incorporated companies, troupes of actors, exhibitors or other like combinations or associations, no more than one (1) license shall be required to be taken out for any one place or premises; but in the case of shows, a license shall be required for each separate show or exhibition when held under a separate canvas or tent.

14. TRADES, ETC. REQUIRING LICENSE:

Each and everyone of the persons hereinafter enumerated shall take out a license in accordance with this Bylaw authorizing them respectively to carry on their respective trades, occupations, callings and business and/or for the keeping for hire or gain any of the articles or things mentioned hereafter within the limits of the Village of Coronach and shall pay therefore to the Village Secretary the respective fee or fees set out in Schedule "A" to this Bylaw.

(1) AUCTIONEER:

Every person or auctioneer selling or offering for sale goods, wares, merchandise, or effects, by public auction. No license to be issued until the required Provincial License has been obtained and produced.

(2) AUDITOR:

Every person or firm who carries on the business of examining and verifying accounts and claims, and who is not assessed on the last revised assessment roll for such business.

(3) AUTO REPAIRER:

Every person carrying on the business of auto repair shop where no general garage facilities are provided.

(4) AUTO CABS OR TAXICABS:

Every person who owns or keeps for hire or gain any automobile or automobile livery or common carrier of passengers,

(5) ADVERTISING SALESMAN:

Every person soliciting advertising for any paper, periodical or magazine, radio station or television station, not having his principal place of business in the Village of Coronach.

(6) BARBER & BEAUTY SHOPS:

Every person carrying on the business of barbering or operating a beauty parlor, or who carries on the business of barber or beautician.

(7) BILL POSTER:

Every person carrying on the business or trade of bill poster, whether owner of such billboard or not.

(8) Bicyclist:

Every person owning, operating or using, or permitting the operation or use of a bicycle on the street of the Village of Coronach.

(9) BILLIARD AND POOLROOM OPERATORS:

Every person who owns or keeps or has in his possession or on his premises for profit any billiard, pool, snooker, bagatelle or other tables or games of like nature, whether the same is used or not.

(10) Blacksmith:

Every person carrying on the business as a blacksmith including wood-work in connection with the blacksmith trade.

(11) Bowling Alleys:

Every person who owns, operates and/or manages a bowling alley for profit or hire.

(12) BOXING, SPARRING OR WRESTLING PROMOTER:

Every person promoting a match or contest of boxing, sparring, wrestling or fencing in which professional contestant or contestants participate.

(13) BUILDING MOVERS:

Every person who carries on the business or occupation of moving houses or other buildings; PROVIDED that no license may be granted unless regulations set forth elsewhere in this Bylaw have been complied with.

(14) BUILDING INSULATORS:

Every person carrying on the business of building insulator, with no place of business in the Village of Coronach.

(15) CANTEENS:

Every proprietor or manager of a canteen in a public place.

(16) CARNIVALS:

Every owner or manager of a carnival whether with or without mechanical rides, sideshows or games of skill or chance.

(17) CHIMNEY SWEEP:

Every person who carries on the business or trade of chimney sweep.

(18) CIRCUSES, MENAGERIES, SHOWS, ETC.:

Every proprietor of any one or more of the following, provided a provincial license is first produced:

- (a) Circus or other like travelling exhibition.
- (b) Menagerie, waxwords, circus riding, rope walking, rope dancing, tumbling or other gymnastic or acrobatic performance, and every common show, exhibition or novelties, wonderful animals, performing animals or other shows exhibited by showmen.
- (c) Hippodrome or wild animals.
- (d) Sleight of hand, legardemanin, juggling or like tricks or like shows.
- (e) Pictures, paintings, statuary, works of art, natural or artificial curiosities, tableaux or freaks of nature.

(19) CHIROPRACTOR:

Every chiropractor or manipulative healer not assessed for the said business on the assessment roll.

(20) COLLECTION AGENTS:

Every person not assessed for business tax other wise, who collects accounts or rentals or manages properties for others and charges a commission therefor, or sells insurance and/or collects any premiums therefor.

(21) CONTRACTORS, SUBCONTRACTORS, ETC.:

Every contractor, sub-contractor, master mechanic, journeyman or jobber, who carries on the business of or enters into any contract for the erection, demolition, alteration or repair of buildings or structures in the Village of Coronach; the installation of heating plants, plumbing or other fixtures; electrical wiring and installation of fixtures; painting and decorating and/or other allied trades and shall include all contractors, sub-contractors, master mechanics or journeymen or jobbers, undertaking any municipal work, whether waterworks, sewage or otherwise; PROVIDED that no license may be issued to anyone engaged in the plumbing and heating trade unless he first obtains and produces a certificate from the Department of Labour for natural gas installations if he is to be engaged in natural gas installations.

(22) DANCE ACADEMY:

Every teacher of dancing operating a hall or other place for the teaching of dancing.

(23) DRAYMEN OR TRUCKING:

Every resident person not on the business tax assessment roll, keeping a dray, truck, cart, wagon or other vehicle, whether motor or otherwise, each of which shall be included in the term and mean dray for hire and use in the transportation of goods, wares, furniture, merchandise and gravel, stone, earth, or any other commodity whatsoever into or within the Village of Coronach or performing any other work for gain.

(24) DRY CLEANER:

Every person carrying on the business of a dry cleaner and/or laundry, or an agent or collector of laundry or processing of the clothing or clothes in a plant located in and operated in the Village of Coronach.

(25) FISH DEALER:

Every person carrying on the trade or business of a fish dealer.

(26) FUR AND HIDE DEALER:

Every person buying or dealing in raw furs or hides, whether separate or in conjunction with any other business in the Village of Coronach.

(27) FISH DEALERS:

Every person who sells or offers for sale coal and/or wood or carries on the business of selling and delivering to the consumer heating oil by tank or drum or any bottled gas for consumption in a heating unit and not assessed for such business on the last revised assessment roll; PROVIDED that the provisions of this section shall not apply to farmers selling wood taken from their own farm.

(28) FUMIGATOR & EXTERMINATOR:

Every person who carries on the business or trade of a fumigator or exterminator.

(29) DEALERS OR SALESMEN NOT OTHERWISE SPECIFIED:

Dealers or salesmen not specifically mentioned in this Bylaw and who do not come under the Commercial Agents Act.

(30) JUNK & SCRAP DEALER:

Every person carrying on the business or trade of a junk or scrap dealer; PROVIDED that the provisions of this section shall not apply to a book seller assessed for such business on the last revised assessment roll from dealing in second-hand books.

(31) LIVESTOCK COMPANY OR DEALER:

Every person trading as a livestock company and conducting and maintaining or operating a stockyard within the Village of Coronach.

(32) MERRY-GO-ROUND OPERATOR:

Every person who owns, keeps or operatedd any merry-go-round or other like temporary place of amusement.

(33) PAWNBROKER:

Every person who carries on the business of pawnbroker in the Village of Coronach.

(34) PIANO TUNER:

Every person carrying on the trade or business of piano tuner.

(35) PUBLIC HALLS:

Every person owning, renting, occupying or managing a hall or halls rented for public dances, private dances, private parties, or other public entertainment, whether used regularly or occasionally, except moving picture theatres.

(36) REFRESHMENT STAND:

Every person who keeps or operates a refreshment stand for the sale of soft drinks, chocolate bars, and other like products and not assessed for the said business on the last revised assessment roll; PROVIDED that no licence may be issued unless and until a certificate from the Sanitary Officer or Medical Health Officer has been first obtained and produced.

(37) SCISSOR GRINDER, KNIFE & SAW SHARPENERS:

Every person who goes from house to house and repairs or grinds scissors, knives, saws or other edged tools or instruments.

(38) SIGNBOARDS, BILLBOARDS AND ADVERTISING DEVICES:

Every person erecting and using, or causing to be erected and used or continuing the use of any signboard, billboard or other advertising device within the Village, PROVIDED that all signs shall be in conformity with the provisions of the Building Bylaws of the Village of Coronach.

(39) SECONDHAND DEALER:

Every person who keeps a shop, store or other premises for the purpose of purchase, sale or exchange of secondhand goods, PROVIDED that no such licence shall be required to be taken out by any bookseller buying and selling secondhand books, who has been assessed for business on the last revised assessment roll.

(40) THEATRES:

Every person who operated for profit any moving picture theatre or opera house.

(41) TRANSIENT TRADER:

Every transient trader as defined by the Urban Municipality Act carrying on any business or trade in the Village of Coronach.

(42) USED CAR DEALER:

Every person carrying on the business whereby used motor vehicles are sold, traded or offered for sale and does not pay any fee or tax in respect to the business of a new car dealer.

(43) TROUPE IN TENT:

Every troupe or company of actors, musicians or other dramatic or musical performance, not being resident of the Village of Coronach and exhibiting in a tent or any other place elsewhere than a building or place duly licenced.

(44) WATCH REPAIRER:

Every person carrying on the business of repairing watches, clocks, etc., not conducted in a jewellery store.

(45) CIGARETTE DEALER:

Every person who keeps or offers for sale cigarettes in any place in the Village of Coronach.

(46) TRAILER COURT OPERATOR:

Any person who for gain uses any parcel of land on which any trailer is placed or intended to be placed, which said trailer when so placed is used or intended to be used for business, living or sleeping quarters,

(47) BICYCLE DELIVERY:

Every person carrying on business of delivery or conveying messages, goods, wares, merchandise, commodities, or personal property of any kind whatsoever by means of a bicycle.

(48) GREETING CARDS:

Every person who sells or offers for sale any greeting cards by sample or otherwise, or solicits orders for their future delivery, and who is not assessed for said business on the assessment roll.

(49) RUG AND/OR UPHOLSTERY CLEANER:

Every person who carries on the business of rug and/or upholstery cleaning.

(50) NOT CLASSIFIED:

Every person carrying on any trade or business for gain if in regard to licensing of same no specific provision is anywhere made in this bylaw and who is not assessed for the purpose of business tax in respect of the said business.

REGULATIONS RESPECTING CERTAIN TRADES

15. AUCTIONEERS: (1) Every auctioneer shall keep proper books of account in which shall be entered the names and addresses of all persons who leave goods, wares, merchandise or effects with him for sale, or for whom goods, wares, merchandise or effects are sold by him, and also the names and addresses of the persons to whom such goods, wares, merchandise or effects are sold, a description of the goods sold and the price obtained for each and every article.

(2) Every licensed auctioneer shall, upon receiving any goods, wares, merchandise or effects for sale at his auction room or elsewhere in the Village, give to the person leaving same with him for sale a receipt therefor containing a description of every article so left with him and the date upon which the same was left.

(3) All books kept by an auctioneer pursuant to subsection (1) and all receipts issued pursuant to subsection (2) hereof shall be open to the inspection of the Licence Inspector or any member of the Village of Coronach Police Department at all times during business hours.

(4) No auctioneer shall conduct a mock auction on his premises or elsewhere in the Village or permit anyone to conduct a mock auction on his premises.

(5) No auctioneer shall knowingly or wilfully make or permit to be made any misrepresentation as to the quality or value of the goods, wares, merchandise or effects he offers for sale.

(6) Every auctioneer shall within a reasonable time after the sale of any goods, wares, merchandise, effects or things, prepare and render to every person for whom such sale is made a full, true and itemized account thereof and shall pay to the person entitled thereto all monies received by him for goods, wares, merchandise, effects or things, deducting there from, however, his reasonable commission and any disbursements actually made by him and specially authorized by the person whose goods, wares, merchandise, effects or things have been sold.

16. BILLIARD HALLS, POOL HALLS & BOWLING ALLEYS:

(1) No licence in respect of any billiard hall, pool hall or bowling alley shall be granted until the premises have been inspected by the Inspector of Licences of the Medical Health Officer and approved as suitable for that purpose.

(2) No business other than billiards, pool or bowling or like games shall be conducted on the premises without first having taken out a licence therefor.

(3) Every keeper of a licenced billiard hall or pool hall shall keep his premises closed and shall not permit any person to play any of the said games therein from 12'o'clock at night until 7:00 a.m. on the following morning, except on Saturday, when the said premises shall be kept and remain closed from 11 o'clock at night until 7:00 a.m. on the following Monday morning, nor shall any person who is not the licensee or his employee be therein.

(4) No licensed keeper of a billiard hall, or other similar place shall suffer or permit any person of either sex, apparently or to the knowledge of such licensee, under the age of fourteen (14) years to play any games in the room or premises wherein the licence is exercised, or to linger or loiter in or about such room or premises.

(5) No person under the age of fourteen (14) years shall play any game or enter into, linger or loiter in or about any room or premises mentioned in subsection (4) of this section.

(6) No person under the age of 14 years, with the exception of coin operated mechanical devices used for played recorded music, shall operate a coin operated device used for entertainment or amusement.

(7) No proprietor, manager or employee of an establishment which contains a coin operated pin ball machine or other coin operated mechanical device shall allow any person under the age of 14 years to operate the said machine.

(8) All machines or coin operated mechanical devices referred to in subsection (6) and subsection (7) shall display a sign on one or all of such machines containing the following words:
"It shall be an offence for anyone under the age of 14 years to operate this machine."

(9) It shall be an offence for any proprietor, manager or employee of any establishment which contains a coin operated pin ball machine or any other mechanical device for entertainment or amusement, to allow any such machine to be exhibited without such a sign displayed as referred to in subsection (8).

17. BUILDING MOVERS:

(1) Every building mover before commencing to move any house or other building or structure on or along any street, lane or other public place within the Village of Coronach shall file application for a permit with the Village office showing in full detail the route along which the said house or other building will be moved.

(2) No house or any other building or structure may be moved until the application mentioned in subsection (1) hereof has been approved and a moving permit granted by the Village Council.

(3) The moving permit shall be in such form as may be determined by the Village Council.

(4) Every applicant for a licence to carry on the business of moving buildings or structures shall, before the licence therefor is granted, file with the Licence Inspector a good and sufficient bond to the Village in the sum of \$10,000.00, in terms and in a form and by a company satisfactory to the Village Secretary-Treasurer, whereby the Village shall be indemnified and saved harmless in connection with any claims, losses, damages, actions or demands, it may sustain directly or indirectly resulting from the granting of the licence or the carrying on of the said business of the building mover.

18. CIRCUS, TRAVELLING EXHIBITIONS, ETC.:

(1) No circus, menagerie, hippodrome, or other like travelling exhibitions, sideshows or other entertainment connected therewith, shall be exhibited in the Village of Coronach for a period longer than one (1) day without permission of the Village Council and unless a separate licence is taken out for each day.

(2) Where refreshments are sold in connection with any show the tariff proposed to be charged for such refreshments shall be exhibited in a conspicuous place or places in the said show, to the satisfaction of the Licence Inspector.

19. PAWNBROKERS & SECONDHAND DEALERS:

(1) Every pawnbroker or secondhand dealer shall keep registry books in such form and containing such information as the Council shall from time to time approve by resolution. These books shall be clearly written up in ink in the English language, giving an accurate description of the goods, articles or things at the time of making any pawn, purchase, loan, sale, redemption or exchange, and shall contain such other information as is required in the form of said registry books.

(2) Every pawnbroker or secondhand dealer shall in the case of a purchase or pawn of a bicycle enter the name of the manufacturer and the serial number of the bicycle.

(3) Every pawnbroker or secondhand dealer shall at the time of the purchase, sale, pawn, redemption, exchange or the receipt of personal property for sale on consignment, issue and deliver to the person so purchasing, selling, pawning, redeeming, exchanging or leaving for sale on consignment any personal property, a receipt, sales slip or pawn ticket containing full particulars of the transaction required to be entered by him to his registry books.

(4) All books and records of every pawnbroker and secondhand dealer shall at all times during business hours be open to inspection by the Licence Inspector and any member of the Village Police.

(5) No pawnbroker or secondhand dealer shall by himself or his employee take or receive in pawn or pledge for money loaned or purchase any goods, articles or things from any person under eighteen (18) years of age, or the ownership of which is in, or is claimed by any such person or which may be in possession or under the control of any such person, without obtaining from such person's parents or guardian an authorization to so dispose of the property.

(6) The Council may by resolution require all pawnbrokers and secondhand dealers to submit to the Village Police daily or otherwise true reports setting forth all personal property that has come into his possession by way of pawn, pledge, purchase or exchange, and shall prescribe the form of report to be used.

20. BICYCLES:

Every owner of a bicycle operated within the Village shall obtain a licence for each bicycle.

The Licence Inspector shall furnish to every person who obtains a licence, a number tag or plate bearing the registered number of the licence, the year during which the licence is in force, and the name "Coronach".

No person shall remove, destroy or mutilate or alter the numbers of any bicycle frame licensed under this Bylaw.

No person, other than the owner of a bicycle, shall remove or destroy the numbered tag or plate fastened thereto in accordance with the provisions of this Bylaw.

The Licence Inspector shall furnish to every person who obtains a licence a set of rules and regulations. Each licensee shall abide by such rules and regulations.

Whenever an infraction of any of the provisions of the general licensing Bylaw relating to the licensing of bicycles within the Village is committed by a child apparently or actually under the age of sixteen (16) years, any member of the Police Force under tract with the Village, in lieu of laying an information respecting such infraction may impound the bicycle in respect of which such infraction was committed, for a period of time in his discretion, not exceeding thirty (30) days.

- 21. REPEAL OF FORMER BYLAWS: Bylaw No. 410 and all amendments thereto of the Village of Coronach are hereby repealed.
- 22. PENALTY: Any person convicted of any breach of the provisions of this Bylaw shall be liable to a penalty of not less than \$10.00 (Ten Dollars) and not more than One Hundred (\$100.00) Dollars, exclusive of costs; and in the case the conviction be for non-payment of a licence fee to the Village under this Bylaw the convicting Police Magistrate or Justice of the Peace may adjudge the payment of such licence fee in addition to the penalty hereby imposed. Such penalty or penalties and licence fee, as the case may be, may be recovered and enforced with costs by summary conviction before a Ploice Magistrate or Justice of the Peace having jur&sdiction within the Province of Saskatchewan, and in default of payment the person convicted may be committed to gaol for a period not exceeding thirty (30) days withoor without hard labour, unless such penalty or penalties and licence fee, as the case may be, and costs of committal and conveyance of the person convicted to the said gaol are sooner paid.
- 23. This Bylaw shall come into force and take effect on the date to the final passing thereof.
