

BYLAW NO. 6/76 Part A

A BYLAW OF THE VILLAGE OF CORONACH, IN THE PROVINCE OF SASKATCHEWAN, TO CLOSE CERTAIN STREETS, LANES AND ROAD ALLOWANCE, OF RECORD IN THE MOOSE JAW LAND TITLES OFFICE ON PLANS EX111, CX870, EX20, IN THE VILLAGE OF CORONACH, SASKATCHEWAN, IN ORDER TO ACCOMMODATE THE PROPOSED RESUBDIVISION

The Mayor and Council of the Village of Coronach, in the Province of Saskatchewan, in open meeting, hereby enact as follows:

"THAT the following streets, lanes, road widening and road allowance be and are hereby closed:

- (a) All of the public highways in the Village of Coronach which lie west of the westerly limit of Fourth Street West as shown upon a plan of record in the Land Titles Office for the Moose Jaw Land Registration District as Number EX111.
- (b) All that portion of Daniels Avenue lying between the production westerly of the south limit of Crawford Avenue and the production westerly of the north limit of South Avenue, as shown on a plan of record in the said Land Titles Office as Number CX870.
- (c) All that portion of Winter Avenue lying west of the production southerly of the easterly limit of Block 13, as shown on a plan of record in the said Land Titles Office as Number EX20.
- (d) All that portion of the road widening as shown on said Plan Number CX870, lying south of the southwesterly limit of the surveyed road as shown on a plan of record in the said Land Titles Office as Number 65MJ11137, and north of a line with a bearing of N 66°54'30" E from the southeast corner of Public Reserve R2 as same is shown on said Plan Number CX870, the east limit of said Public Reserve having a bearing of Assumed North.
- (e) All that portion of the original road allowance east of and adjacent to the North East Quarter (NE $\frac{1}{4}$) of Section Ten (10), Township Two (2), Range Twenty seven (27), West of the Second Meridian, lying south of the southwesterly limit of the surveyed road as shown upon a plan of record in the Land Titles Office for the Moose Jaw Land Registration District as Number 65MJ11137 and north of a line with a bearing of N 66°54'30" E from the southeast corner of Public Reserve R2 as same is shown on a plan of record in the said Land Titles Office for the said Land Registration District as Number CX870, the east limit of the said public reserve having a bearing of Assumed North."

READ A SECOND TIME this 10th day of August, 1976.
