


BYLAW NO. 6 of 1983

A BYLAW OF THE TOWN OF CORONACH TO  
AMEND BYLAW NO. 5 of 1976 ( THE  
LICENSE BYLAW)

The Council of the Town of Coronach hereby enacts  
as follows:

1. Bylaw No. 5 of 1976 is amended as hereinafter set forth.
2. Section 6 - License Fees - is amended by deleting the words "Schedule 'A' " in the second line and substituting therefor the words "Schedule 'A-1' ".
3. Section 22 - Penalty - is amended by deleting the words "\$10.00 (Ten Dollars)" in the second line and substituting therefor the words "One Hundred (\$100.00) Dollars" and amended further by deleting the words "One Hundred (\$100.00) Dollars" in the third line and substituting therefor the words "Five Hundred (\$500.00) Dollars".
4. Schedule "A-1" shall be appended to and form a part of this bylaw.
5. This Bylaw shall become effective on the first day of January, 1984.
