## BYLAW 3.2025 A BYLAW OF THE TOWN OF CORONACH TO ESTABLISH A TRANSFER SITE AND TO REGULATE AND CONTROL THE DISPOSAL OF WASTE IN THE TRANSFER SITE

The Council of the Town of Coronach, in the Province of Saskatchewan, under the authority of *The Municipalities Act*, enacts as follows:

#### 1. Transfer Site Dumping Rates:

Clear Bagged Household Garbage (no household food or waste/scraps allowed)	\$5.00 per bag up to 10 bags, then priced at \$100/load (over 10 bags)	
Furniture (recliner, children's furniture, coffee table)	\$20.00 per piece	
Furniture (couch, mattress, box spring, large items)	\$30.00 per piece	
Demolition or Mixed Construction Materials (includes lumber, treated wood, painted wood, glass, windows, mirrors, insulation, wire, gyprock, etc):		
In a Pickup Truck or Utility Trailer	\$100.00	
In a Pickup Truck/Utility Trailer with Sides (with extensions added)	\$150.00	
Mixed Loads (garbage, wood, furniture, etc)	\$150.00	
In a One Ton Truck (contains box & hoist)	\$200.00	
3 Ton Truck	\$500.00	
Small Appliances (fans, leaf blowers, sewing machines, coffee makers, non-metal sinks, toilets, water dispensers, vacuums, air cleaners, deep fryers etc.)	\$10.00 per piece	
Large Appliances (water softeners)	\$25.00 per piece	
All Other Metal Appliances are No Charge. (Range hoods, microwaves, convection ovens, stoves, washer, dryer, water heaters, furnaces, water heaters, BBQ's)	Free- placed in marked metal pile	
Refrigeration Appliances <u>tagged Freon Free</u> (Fridges, Freezers, Air Conditioners)	Free- placed in marked metal pile	
Scrap Metals (not including barbed wire)	Free	
Trees, branches, garden waste in paper or compostable bags	Free	
Grain Bags	Free- to be placed in designated area	
**Compost/garden waste in non-compostable bags	\$20.00	

All fee decisions by the contractor at the Transfer Site office are final and are supported by the Town of Coronach Council. Transfer Site charges put on account must be paid within 5 business days to the Town office. Upon nonpayment within 5 days, an Accounts Receivable notice will be sent to the person. If a person of the Transfer Site has unpaid charges on account at the Town office after 5 days, dumping privileges will be suspended until payment is received at the Town office.

#### 2. Materials that are not allowed:

- Any Material that can be recycled at Sarcan Services (i.e. electronics and paint)
- Household food waste/scraps
- Animal Carcasses, hides, or manure
- Antifreeze/Antifreeze Containers
- Asbestos
- Asphalt
- ATV Bodies, Garden Tractor Bodies, Motorcycles and Snowmobiles
- Batteries

- Concrete
- Fuel Tanks
- Grain
- Granaries
- Hazardous Waste (includes but not limited to herbicides, noxious chemicals, lubricants, oil-based paints and containers holding these materials)
- Liquid Domestic Waste, including sump and hydrovac waste
- Propane Bottles
- Pesticide Containers
- Railroad Ties
- Vehicle Bodies
- Used Oil, Oil Filters and Containers
- Contaminated Soil
- Scrap Tires (shall be disposed at a Tire Recycling Depot)
- Shingles
- Infectious/biomedical waste
- Explosives, combustibles, compressed gas containers
- Any material not listed under section 1 of the Bylaw, is prohibited pending prior arrangement with the Transfer Site contractor. The Transfer Site contractor will refuse the disposal of any unknown substance that is deemed to be potentially hazardous to the environment.
- 3. Fluorescent bulbs, 4 ft. and 8 ft. can be delivered and placed in the blue barrel behind the Town Office, 212 1st Street East, at no charge.
- 4. The Transfer Site provided by the Town is the only place authorized for the disposal of excess refuse and certain recycling materials (grass clippings, branches, trees, metal).
- 5. The appointed Transfer Site contractor may inspect all waste brought to the Transfer Site to determine if the load contains unacceptable waste or recyclable material. If a person refuses the inspection, the contractor will be instructed to deny the person access for disposal.
- 6. Any person(s) entering the Transfer Site are required to complete a row on the "Transfer Site Log Sheet", which will be provided from the contractor to the person. If a person refuses to fill out the row, the contractor will be instructed to deny the person access for disposal. These sheets are required by the Ministry of Environment for permitting the site.
- 7. Every person who attends the Transfer Site shall report to the contractor, comply with instructions, and provide proof of payment.
- 8. If a person is disposing of a mixed load, it must be sorted by the person wishing to dispose of the waste into the appropriate designated areas.
- 9. Person(s) using abusive or threatening language or gestures may be refused access to the Transfer Site at the discretion of the contractor.
- 10. No person is to dispose of refuse or recycle materials around the perimeter of the Transfer Site.
- 11. Where a person disposes of waste or recyclable material contrary to the terms of this Bylaw, the Town may remove the waste and the costs of so doing are a debt to the Town from the person who disposed of the waste.
- 12. The Transfer Site bins shall be maintained by a waste collector/contractor as determined by Council.
- 13. The Transfer Site is only open to Town of Coronach and RM of Hart Butte #211 residents.

- 14. Outside of regular scheduled hours to the Transfer Site, materials may be accepted at the discretion of the contractor, for a flat fee of \$ 75.00 per occurrence (plus appropriate Transfer Site fees).
- 15. The following are operating limitations due to weather. The Transfer Site will be closed in the following weather-related circumstances to ensure the safety of the contractor:
  - a) The outdoor temperature is colder than -20C (plus wind chill);
  - b) The outdoor temperature is higher than 26C and/or the reported humidex is higher than 38; or,
  - c) There has been more than 30mm precipitation in the 24 hours in advance of the scheduled open hours, whether rain or snow.

#### 16. Anti-Dumping

- a) No person shall dispose of waste anywhere in the Town other than in a waste container or at the Transfer Site. A person who has placed waste contrary to the provisions of this Bylaw shall remove the waste or cause the waste to be removed.
- b) No person who transports or causes to be transported any waste in the Town shall allow the waste or any portion of it to escape from the vehicle.
- c) No person shall transport or cause to be transported any waste in the Town unless proper measures, including at least one of the following, are taken to prevent the waste or any portion of it from escaping the vehicle:
  - i) the waste is covered;
  - ii) the waste is in a covered container; or,
  - iii) the waste is securely tied down or fastened.
- d) To regulate and control the dumping of refuse and waste material on property:
- i) No person shall dump or dispose or cause to be dumped or disposed any waste on any property owned or under the jurisdiction and control of the Town, without first securing written permission from Town Council:
  - 1) areas designated by sign as the Transfer Site for the disposal of waste;
- 2) any person removing snow, ice, or water from a sidewalk abutting his or her premises and depositing such waste upon any abutting boulevard, lane, or street;
- 3) any person removing leaves, branches, weeds, or garden vegetation from his or her property and depositing such waste on the boundary of any lane abutting their property.
- e) Any person who disposes or dumps waste contrary to this Bylaw shall be guilty of an offence and liable to a fine on summary conviction of not less than \$500.00, but not more than \$1000.00.
- f) In addition to the fine levied on summary conviction proceedings, the person convicted of a breach of this bylaw shall be responsible for the removal of any waste dumped or disposed contrary to this bylaw.
- 17. The hours of operation will be set out by the Town and be posted on the Town website and at the Transfer Site. The Transfer Site is located on the Poplar River Mine Road. The Transfer Site is located at SW-18-02-26-W2M in the Province of Saskatchewan.
- 18. Except as otherwise provided for in this Bylaw, no person shall set fire to, or burn, any refuse in the Transfer Site.
- 19. The Coronach Fire Association (Fire Department) has been granted permission to practice on the land within the boundary of the Transfer Site as a fire fighting training ground to practice fire fighting techniques/skills.
- 20. Subject to approvals granted from time to time by the Ministry of Environment, clean wood waste shall be the only refuse burned at the Transfer Site and shall be burned only by the Public Works Department of the Town.
