BYLAW 10.2025

A BYLAW FOR THE OPERATION OF A GOLF CART ON PUBLIC ROADWAYS WITHIN THE LIMITS OF THE TOWN OF CORONACH

Subject to and in accordance with Section 113.1 of *The Traffic Safety Act* and *The Registration Exemption and Reciprocity Regulations* (2014).

The Council of the **Town of Coronach** in the Province of Saskatchewan enacts Bylaw No. 10.2025 as follows:

1. This bylaw may be referred to as the "Golf Cart Bylaw."
2. That all the provisions and enactments set form in this bylaw shall relate to and be in full force and effect within the limits of the Town of Coronach.

3. Definitions: In this Bylaw:

a) A Golf Cart is a vehicle as defined in *The Registration Exemption and Reciprocity Regulations*.

"Golf Cart" means a self-propelled vehicle that:

- i) is designed to transport passengers and their equipment within the limits of the Town of Coronach;
- ii) has three or more wheels;
- iii) cannot be operated at a speed of more than twenty-four kilometers per hour on level ground; and,
- iv) has an unladen weight of less than five hundred ninety kilograms;

but does not include:

- v) an all-terrain vehicle as defined in *The All Terrain Vehicles Act*; or
- vi) a low-speed vehicle as defined in the *Motor Vehicle Safety Regulations*, C.R.C., c.1038.

4. Scope

a) It shall be lawful to operate a Golf Cart during the daylight hours from one half hour before sunrise until one half hour after sunset on all roadways within the limits of the Town of Coronach after obtaining a permit of fifty dollars from the Town Office.

b) The permit shall expire on December 31st of the year that it is issued, and permit renewals shall be due on February 15th of each year.

c) Permits shall not be issued or renewed until proof of insurance has been provided and shall be in a form deemed suitable by the Administrator or their designate.

d) The owner of the Golf Cart must insure themselves and every other person, who, with the owner's consent, operates that Golf Cart, against liability by law arising out of ownership, use or operation of that Golf Cart and provides proof of insurance at the request of a peace officer. The minimum liability requirement is \$200,000 in third party liability coverage.

e) Persons operating a Golf Cart on the roadways within the limits of the Town of Coronach must not operate the Golf Cart on any provincial highway (Highway #18), other than to cross. Golf Carts cannot operate on any roadway with a posted speed over fifty kilometers per hour.

f) Golf Carts shall display a slow moving vehicle warning device, as defined by Section 2(1)(kk) of *The Vehicle Equipment Regulations* (1987), at the rear, as near to the center as practicable with one side parallel to and not less than 900 millimetres nor more than 1,500 millimetres from the ground. The Town of Coronach will provide a sticker upon issuance of the permit which shall be attached to the slow-moving vehicle warning device.

g) No person shall operate a Golf Cart on the roadways within the limits of the Town of Coronach without a valid driver's license. All drivers of a Golf Cart must hold a minimum of a valid Class 7 driver's license, to abide by all Saskatchewan Government Insurance (SGI)

regulations and requirements, and follow stipulations as stated under Section 113.1 of *The Traffic Safety Act*.

h) Any person who contravenes any of the provisions of this Bylaw is guilty of an offence and liable on summary conviction to a fine of not less than \$150.00 and not more than \$1,000.00.

i) All offences and fines for not following the rules of the road under *The Traffic Safety Act* and regulations apply when operating a Golf Cart. If convicted of an offence while operating a Golf Cart, it would be applied to the driving record and impact the operator's Safe Driver Recognition rating through SGI.

j) The Town of Coronach will monitor and inform SGI of any collisions that occur and if there were any injuries or fatalities.

k) Golf Carts must be operated in accordance with the rules of *The Traffic Safety Act* and any municipal bylaw related to traffic. Federal and provincial impaired driving laws also apply to the operation of a Golf Cart.

l) Bylaw 8.2019 is hereby repealed.

m) This Bylaw shall come into force and take effect upon approval thereof by Saskatchewan Government Insurance.
